### **About Us**

### The Beginning of GCA

Gaston Community Action, Inc. is a private non-profit corporation chartered by the State of North Carolina to operate anti-poverty programs in Gaston County on October 22, 1964. Structured in accordance with standards and requirements of the Federal Economic Opportunity Act of 1964 and subsequence amendments. Community Action Agencies equip low-income citizens with the tools and potential for becoming self-sufficient. The structure of programming is unique: federal dollars are used locally to offer specialized programming in communities. It is a coordinated effort to address the root effects of poverty and to, ultimately, move families and individuals to self-sufficiency.

### Agency Overview

The agency administers programs in Cleveland, Gaston, Lincoln, and Stanly Counties. Funded by the U.S. Department of Health and Human Services and Human Services Administration for Children and Families, North Carolina Department of Health and Human Services of Economic Opportunity. GCA employs a staff of about 120 and operates on an annual budget of over 7 million.

GCA has continuously provided services and advocacy on behalf of the poor and disadvantaged since its inception and charter. Our programs are planned after holding public hearings to solicit community input. Head Start educates 431 preschool children in Gaston and Lincoln Counties. The CSBG program is directed toward making low-income residents of the four counties self-sufficient by providing help with employment, housing, education, and transportation.

### Letter from the CEO's desk

Chief Executive Officer Letter

A moment of reflection brings to mind what happened to the entire world in 2020. Most people would say the pandemic offered all of us greater challenges that we would have not chosen. Yet, it is in that moment Gaston Community Action, Inc. (GCA) greatest challenge that we learned and grew into a new way of doing things.

The world was attacked by a virus that no one was familiar with. The Governor of North Carolina shut down the state and only allowed essential employees to work. Gaston Community Action, Inc. is and was considered to be an essential organization. Therefore, the staff of GCA had to continue to serve our clients.

Policies to ensure the quality of services and safety for the clients and staff were developed and implemented. Every area of GCA's operation, from administration to programmatic, had been impacted. Gaston Community Action, Inc.'s Board of Directors and staff came together. A plan for success was mapped out as to how GCA can continue to serve our clients in Cleveland, Gaston, Lincoln, and Stanly Counties.

GCA applied for a Federal Grant from the Health and Human Services (HHS) to operate a Head Start Summer Program during COVID-19 and was approved. The GCA and Head Start staff took on the challenge and did what was necessary to keep our children in a safe environment. Everyone, including the children and the staff, were required to wear a mask; wash and clean their hands often. Centers were cleaned and sterilized each day before the children returned.

Additional funding provided from the Health and Human Services allowed GCA to assist families that were affected by COVID-19. The services provided assistance with housing, food, clothing, and transportation, education tuition, rent and mortgage assistance.

No matter what devastation may come our way, Gaston Community Action, Inc. will not give up on providing our clients with a high-quality service. Although the pandemic is being better managed, we will continue to stay abreast of meeting the needs of our communities and seek funding to address those needs.

#### GCA'S APPROACH TO SCHOOL READINESS GOALS FOR CHILDREN

Head Start defines school readiness as children possessing the skills, knowledge, and attitudes necessary for success in school, for later learning, and life. The Head Start approach to school readiness means that children are ready for school, families are ready to support their children's learning, and schools are ready for children.

Gaston Community Action, Inc. Head Start is committed to ensuring that children who leave our Head Start program are prepared when they enter the kindergarten program in the public schools. The teaching staff use various strategies including the Classroom Learning Assessment System (CLASS) observation tool to enhance best practice to ensure all children enrolled are working toward meeting goals in all domain areas. These domain areas are assessed daily. The five essential domains are:

- Approaches to Learning and Play
- Social-Emotional Development
- Cognition and General Knowledge
- Language Development and Literacy Knowledge and Skills
- Physical and Health Development

With the implementation of these domains, GCA HS will ensure that children (including those with disabilities) are fully equipped with the necessary skills to successfully transition to kindergarten. The training and mentoring of teaching staff are critical in meeting school readiness goals. Parents are included in goal setting in order to help the child's progress.


Financial Audit Results: For the year ended June 30, 2021, the auditor issued an unmodified opinion. There were no financial statement findings and no questioned costs.



### **401 Families Served**


Gaston Community Action, Inc. Head Start served 401 families. 228 are single-parent families; 70 are two-parent families; 7 are homeless and 5 are foster families.





Gaston Community Action, Inc.'s Head Start is funded through the Department of Health and Human Services, Administration for Children and Families, Office of Head Start. Our funded enrollment is 431 children. Children who leave the program are replaced by those on a waiting list.

#### PARENT ENGAGEMENT/MALE ENGAGEMENT

Gaston Community Action, Inc. Head Start strongly encourages parent participation. Parents are their child's first teachers and are the key to the design and success of the program. Parents are encouraged to participate in a variety of activities, including:

- Parent/staff zoom meetings and trainings for male involvement
- Policy Council meetings
- Parent-teacher conferences
- Virtual home visits
- Center volunteer
- Parent/Staff virtual trainings held monthly

The program provides newsletters and a monthly calendar to parents that include upcoming events. The menus are posted weekly, breakfast, lunch, and snack. The center news and other items of interest are also posted on the Head Start Facebook page.



#### TRANSITION TO KINDERGARTEN

### Preparing Children for Kindergarten

172 children transitioned to Kindergarten in May 2022. Transition meetings are held in April of every year to assist parents of children who are moving on to kindergarten. The local public and charter schools schedule meetings to familiarize the families with the setting, and to routines, to make choices. **Parents** were given opportunities to ask questions and participate in activities. Transition includes sending documentation containing all the health developmental and educational information for the child to their assigned school if requested.

#### **Collaboration Agreements**

Gaston Community Action, Inc. collaborates with two LEAs (Gaston and Lincoln) in our service area. These agreements help coordinate disability services for children who required needed services from these local school systems.

### PROGRAM NOTICE AWARD FOR FIVE-YEAR HEAD START PROJECT PERIODS

The Office of Head Start (OHS) is moving from indefinite project periods to five-year project periods for all Head Start grantees. This requires changes in OHS funding practices and oversight of Head Start Programs. Changes oversight will include in improved communication between federal staff and grantees, as well as ongoing analysis of data to determine the type of support needed by grantees. The main purpose improved oversight is demonstrate the quality of services, the program effectiveness of management systems, and the achievement of outcomes for children, families, and communities. This is our agency's first (3) year of the five (5) year period beginning July 2019. We are in

2021 - 2022 Outcomes

GCA operates the Total Family Achievement Program (TFAP) with federal funds from the Office of Community Services (OCS) under the Community Service Block Grant (CSBG), administered by the NC Department of Health & Human Services (NCDHHS) under the Division of Office of Economic Opportunity (OEO).

The CSBG program is designed to alleviate the causes and conditions of poverty in communities in efforts to promote self-sufficiency. TFAP utilizes CSBG funds to serve the counties of Cleveland, Gaston, Lincoln, and Stanly with a vision of providing quality services to empower families to eliminate barriers to success, and a mission to teach and reach communities through resources and education.

In July 2020, OEO was able to disseminate and administer the CARES Act supplemental funding from OCS to CSBG programs across the state of NC, to assist additional families during the COVID-19 pandemic with economic financial hardships under the CARES NC program. The CARES program specifically targets COVID-19 affected individuals and families in the community with income eligibility below the 200% income poverty guideline from 7/01/2020 through 09/30/2022. This funding supports a range of emergency assistance activities including employment, education, health, transportation, housing, and other activities that may have served as a basic survival need adversely affected by the COVID-19 pandemic.

GCA CSBG program had a targeted goal to serve 200 individuals and families with CARES funding. From 2020-2022 operating years, GCA CARES Program was able to exceed this goal and assist a total of 364 individuals and families.

During the 2021-2022, a total of 448 individuals and families received assistance with both CSBG funding programs.






During this time of uncertainty, Gaston Community Action, Inc. (GCA) stepped up to the challenges facing our organization and the families in the communities where we serve and the staff remained fully committed to helping people and changing lives.

One of the most critical parts of community-based human services infrastructure was preparing to respond and leverage a wide range of funding to best utilize the impact of those dollars in the community and help to build community resilience.

GCA finance department administered and managed a range of federal, state and local funding streams, blending those resources to fill gaps in services and to maximize the impact of each dollar. The experience of the administrative staff along with sound fiscal management practices provided the capacity to quickly receive, track and disburse funds to those most in need of resources.

Additional funding was provided by the US Department of Health and Human Services, the NC Department of Health and Human Services, NCCAA with the Duke Endowment funding, NC Division of Child Development, USDA and NC Pre-K funding.

The additional funding has been utilized to help staff and families experiencing financial hardships, provide materials to promote remote learning, and upon return to the classrooms and work environment, funding was used for cleaning and sanitizing and personal protective equipment and to provide training to address situations that we had not experienced before. We have learned over the past couple of years that where there is a need, there is a way to address it, even if it is something the agency has never done before. Relationships were developed and strengthened as we all used the power of teamwork, conviction, commitment, resolve and creativity to address problems that impacted all of our lives.
